Gary Henry

The Board of Directors of the Chautauqua Region Economic Development Corporation meeting at the Fredonia Technology Incubator at 214 Central Avenue Building in Dunkirk NY and also via Live Stream on YouTube and Zoom. It is March 28, 2023 at approximately 11:18 a.m. We will have a call to order. Roll call vote.

You should have already received the minutes from the February 28, 2023 meeting and had a chance to review those. Does anyone have any questions on the minutes? Hearing none I will take a motion to approve the minutes.

Opposed? So moved. We will move into New Business A.

Mark Geise

I'll take the first half of this and then Nate will take the second half of this. The first Resolution is the acceptance of a grant from the Ralph Wilson Foundation for \$258,000. So, the County allocated funding to the

IDA back a year plus ago from ARPA -\$285,000 that was used to help businesses with grants. We worked with the Chamber, SBDC, we put out marketing information and took applications. It was to help companies upgrade their marketing. What we saw during Covid is that the businesses that were able to pivot and do a lot more social media and online were more successful coming out of Covid than the ones that weren't. We thought this would be a great use of this money to help these companies. We took that \$285,000 and we put it on these grants and we helped over thirty businesses – very grateful-we got a lot of letters, but what we had was a long waiting list. There were forty, fifty or more businesses that missed the cut. So, we said we are going to redouble our efforts put it back out there and see if we can find more money and coordinate with SBDC and myself, Nate, Crystal, Monica and others worked on this grant application to Ralph Wilson and we awarded \$258,000. So, that's going to get us down the list another 25 or so businesses. We have all their names and applications. The Chamber is reaching out to finding out where they are, if they did the upgrades they wanted to do and if not, what other types of marketing things can they do. We should be able to help 25 more businesses or so and we still have a waiting list. Unable to hear audio due to technology issues. So this is to accept that money. We already have the whole process all set. We already have all the applications and this is over two years. This money is over two years from the Ralph Wilson. We think we are going to be able to get it out quickly. That's the first one.

Nate Aldrich

Just to add on to that before I discuss the Marketing New York Grant, a great partnership with the Chamber and the SBDC. Also, thank you to the Ralph Wilson Foundation. I think we have a proven track record with them from our multi-year million dollar grant through the Partnership. Certainly very appreciative of this grant and hopefully more partnerships with that to come in the future. Tagging onto what Mark said, the \$75,000 in Empire State Development Market New York again – the whole idea of the Partnership we built our main driving force is resource development. How can we turn \$1 into \$5? We've shown that. This is just another example how we coddled together \$75,000 through Occupancy Tax and Partnership dollars to secure a \$75,000 grant focused on a two or three year campaign working with the Visitors Bureau, Lake Erie Wine Country and others just to emphasize craft beverage and ecotourism-assets in the County on both the Tourism and Quality of Life perspective-Mark talked about our talent attraction efforts. Again, excited to receive these funds and we will be putting them to use this year and over the course of the next year.
