Written comments were provided to the Hearing Officer by Mayor Kurt Lindstrom prior to the Public Hearing.

HEARING OFFICER: Good morning. My name is Kristine Morabito, and I am the Project Manager for the County of Chautauqua Industrial Development Agency (hereafter, the "Agency") and I have been directed by the members of the Agency to hold a public hearing. Today is February 5, 2013 and the time is now 9:00 a.m. We are at the Courtroom at Silver Creek Village Hall, 172 Central Avenue, Silver Creek, New York, County of Chautauqua, 14136.

This is a public hearing pursuant to section 859-a of the New York General Municipal Law, as amended. The Agency has received an application for financial assistance in connection with the following matter:

S. Howes, Inc., a corporation existing under the laws of the State of New York (the "Applicant"), presented an application (the "Application") to the Agency, which Application requested that the Agency consider undertaking a project (the "Project") consisting of the following: (A) (1) the acquisition of an interest in an approximately 1.7 acre parcel of land located at 25 Howard Street, Silver Creek, County of Chautaugua, New York (collectively, the "Land"), (2) an approximately 8,100 square foot expansion and facade renovation of an existing approximately 20,000 square foot building located on the Land (collectively, the "Building"), and (3) the acquisition and installation therein and thereon of certain furniture, fixtures, machinery and equipment (the "Equipment"), all of the foregoing for use by the Applicant as a manufacturing facility (collectively, the "Project Facility"); (B) the granting of certain "financial assistance" (within the meaning of Section 854(14) of the Act) with respect to the foregoing, including potential exemptions or partial exemptions from sales and use taxes, mortgage recording taxes and real property taxes (but not including special assessments and ad valorem levies) (collectively, the "Financial Assistance"); and (C) the lease (with an obligation to purchase) or sale of the Project Facility to the Applicant or such other entity as may be designated by the Applicant and agreed upon by the Agency.

Notice of this public hearing was published in *The Observer* on January 26, 2013 and provided to the Chief Executive Officer of each affected tax jurisdiction.

The purpose of this hearing is to provide an opportunity for all interested parties to present their views, both orally and in writing, with respect to the Project.

Is there anyone wishing to be heard with respect to the Project?

(Inaudible conversation in background)

HEARING OFFICER: I'll keep the meeting open for 15 minutes for anyone that wishes to make comments.

TOM GOULD: I went over the project a little bit with them. Do they have a final plan of what they want to do?

HEARING OFFICER: I do not have a copy of it.

TOM GOULD: Ok

HEARING OFFICER: I don't, I don't require it at this point in time.

KURT LINDSTROM: But you were explaining that it is tying to all three buildings?

HEARING OFFICER: At least one, possibly two or three, and I again haven't

KURT LINDSTROM: Right

HEARING OFFICER: heard the final plan.

TOM GOULD: That's the way I understood it. Going across, you know, taking up some of the parking, closing it in, (inaudible), expanding. Any expanding in Silver Creek is good.

KURT LINDSTROM: It is.

TOM GOULD: Except when we (inaudible) tops, right?

NICK PICCOLO: Their office building that's currently in existence, all right, that is going to be totally renovated?

HEARING OFFICER: I guess I want to preface my comment by saying it's not really a question and answer session.

No one has indicated a desire to comment beyond the comments that were previously made. I'd like to thank the members of the public for attending this public hearing and I now call this hearing to a close.
