Meeting was called to order by Gary Henry, Chairman, at 11:55 a.m.

Gary Henry

We'll go ahead and move open the Board of Directors Meeting for the Chautauqua Region Economic Development Corporation. We are at the BWB Building, 201 West Third Street, Jamestown NY. We are also streaming live via YouTube and Zoom. It's November 19, 2024 and it's currently 11:55 a.m. We'll go ahead and do Roll Call.

Opposed? The minutes have been approved. We'll move into New Business A. The Resolution regarding – I'll just read it.

Resolution 11-19-24-12 of the Members of the Chautauqua Region Economic Development Corporation Approving Entry into Agreement with Chautauqua County and Local Foundations for Grant Funding for the Chautauqua County Partnership For Economic Growth

Nate Aldrich

Thank you, Mr. Chairman, I'll just go through this really quickly. This is really just kind of an Annual Housekeeping Resolution. You know, the Board authorizing us to accept this funding and to expend it. So, the first funding award here that we anticipate approval by the Northern Chautauqua Community Foundation by the end of the year -their 5th allocation of a hundred thousand dollars the past 5 years. So, this will be, you know, half a million dollar commitment from them to the Partnership. Again, really just providing support for our administrative capacity and the operating expenses of the Partnership that will be for 2025. The Gebbie Foundation provide \$80,000, and again, that offsets some of our operating expenses specifically related to the Chadakoin River Activation Initiative. That will also be the, I believe, 4th year of that allocation. As Mark mentioned last month, we were approved for another three year grant for our Ralph Wilson support in the amount of \$1.625 million. This both supports the Partnership's operating expenses and specific projects aligned with our economic development strategy. Then the last two we anticipate approval by the County Legislature tomorrow night again \$30,000 that primarily supports our contractual relationship with Jacob Bodeway and all the work he does to leverage local and philanthropic funding to improve our trail - outdoor recreation assets. Again, we reported to the Legislature last week with Jacob's involvement, we've seen over \$850,000 of investment in about the last 4 years or so - trails. So we thank the County Executive for his support of that allocation, as well as additional \$50,000 also from our 3% Occupancy Tax which is meant to help the Partnership do its work related to community development, downtown revitalization and waterfront attraction. So, with these five total awards again asking for your acceptance totals \$1.89 million dollars and again puts us in a good position to keep doing what we're doing via the Partnership.

Awesome. Thank you. Dan Heitzenrater would you move New Business A for us?

So, good job, great job, Nate.

Yeah, this is all you know - setting all this stuff up is a real - t's been a challenge because we didn't have to track things like this before and with each and every funding source you know, you need to track them independently. So, setting up all these different fund codes and ledgers and tracking everything and there's different timing of when the money comes in and what's your annual - you know - but we're getting better and better, right? Better and better. We're not perfect but we're getting better and better. Now we're meeting monthly and talking through all these things and making sure that we're staying on top of it - fixing things where they're not right.

Aye Unanimous.


